### **1. The interested party or the person from whom personal data is collected are informed orally or in writing in advance:**

#### **1.1 The purposes and methods of processing for which the data are intended;**

In accordance with Legislative Decree 196/2003 we inform you that the data you provide us with will also be processed electronically, protected by a firewall system and protection from computer attacks, to allow us to:

- a. reply to your requests for information;
- b. send you communications and information regarding the initiatives and services of Vibrowest Italiana Srl.

#### **1.2 The obligatory or optional nature of providing data;**

The provision of personal data is optional, refusal to do so shall have no consequences except for the impossibility to use the services and information offered by Vibrowest Italiana Srl. In order to receive our newsletter it is sufficient to indicate only your e-mail address while the other fields are optional and/or can be filled in by indicating pseudonyms and/or invented words.

#### **1.3 The consequences of a possible refusal to reply;**

the non-conferment of data does not imply any consequences.

#### **1.4 The storage period of the data;**

- a. personal data processed and stored for contractual and pre-contractual purposes are processed for a period not exceeding 10 years from the termination of the contract, in case of conclusion of the same and, in case of mere pre-contractual negotiations, for a period not exceeding 10 years from the termination of negotiations.
- b. Personal data processed and stored for the purposes of fulfilling legal obligations shall be processed and stored for a period not exceeding 10 years from the termination of negotiations, unless, in any case, different provisions of law.

#### **1.5 The entities or categories of entity to whom or which the personal data may be communicated or who or which may get to know said data in their capacity as data processors or persons in charge of the processing, and the scope of dissemination of said data;**

the data will not be communicated to anyone.

- 1.6 Vibrowest Italiana Srl respects all the rights of the interested party mentioned in the articles of this document.**
- 2 The interested party has the right to obtain confirmation of the existence or not of personal data concerning him/her, even if not yet recorded, and their communication in an intelligible form.**
- 3 The interested party has the right to obtain the indication:**
- 3.1 the origin of the personal data;
  - 3.2 the purposes and methods of processing;
  - 3.3 the logic applied in case of processing carried out with the aid of electronic instruments;
  - 3.4 the identification details of the holder, the persons responsible and the representative appointed pursuant to Article 6, paragraph 6.1;
  - 3.5 the entities or categories of entity to whom or which the personal data may be communicated and who or which may get to know said data in their capacity as designated representatives in the State's territory, data processors or persons in charge of the processing.
- 4 The interested party has the right to obtain:**
- 4.1 the updating, rectification or, when interested therein, the integration of the data;
  - 4.2 the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed;
  - 4.3 certification to the effect that the operations as per letters a) and b) have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected.
- 5 The interested party has the right to object, in whole or in part:**
- 5.1 for legitimate reasons to the processing of personal data concerning him/her, even if pertinent to the purpose of collection;
  - 5.2 to the processing of personal data concerning him/her, where it is carried out for the purpose of sending advertising materials or direct selling or else for the performance of market or commercial communication surveys.

## Extended information on the use of cookies

### Use of cookies

The "Site" [vibrowest.it](http://vibrowest.it) uses **cookies** to make its services simple and efficient for users who view the pages of [vibrowest.it](http://vibrowest.it).

Users who view the Site, will see minimum amounts of information inserted in the devices in use, which are computers and mobile devices, in small text files called "cookies" saved in the directories used by the User's web browser.

By disabling cookies some of our services may not work properly and some pages will not display them correctly.

There are **various types of cookies**, some to make your use of the Site more effective, others to enable certain features.

By analysing them in detail our cookies allow you to:

store your preferences

avoid re-entering the same information several times during the visit such as user name and password

analyse the use of the services and content provided by vibrowest.it to optimise the browsing experience and the services offered.

### Types of Cookies used by [vibrowest.it](http://vibrowest.it)

Below are the various types of cookies used by [vibrowest.it](http://vibrowest.it) according to the purpose of use

#### Technical Cookies

This type of cookie is strictly necessary for the **correct functioning of certain sections of the Site**.

There are two categories: persistent and session cookies:

persistent: once the browser is closed they are not destroyed but remain until a preset expiry date of sessions: they are destroyed every time the browser is closed.

These cookies, always sent from our domain, are **necessary to correctly display the site** and in relation to the technical services offered, will therefore **always be used and sent**, unless users change the settings in their browser (thus affecting the display of the site pages).

#### Analytical cookies

Cookies in this category are used to collect information about the use of the site. vibrowest.it will use this information for anonymous statistical analysis in order to improve the use of the Site and to make the content more interesting and relevant to the wishes of users. This type of cookie collects anonymous data on user activity and how it arrived on the Site. Analytical cookies are sent by the Site itself or by third party domains.

#### Analytical cookies of third party services

These cookies are used to collect information on the use of the Site by users anonymously such as: pages visited, time of stay, origin of traffic, geographical origin, age, gender and interests for marketing campaigns. These cookies are sent by third party domains outside the Site, in our case by Google Analytics.

Cookies to integrate third party software products and functions

This type of cookie integrates features developed by third parties within the pages of the Site such as icons and preferences expressed in social networks in order to share site content or to use third party software services (such as map generation software and additional software offering additional services). These cookies are sent by third party domains and partner sites that offer their functionality between Site pages.

#### Profiling cookies

These are those cookies necessary to create user profiles in order to send advertising messages in line with the preferences expressed by the user within the pages of the Site.

## How to disable cookies by configuring the browser

### 1. Run the **Chrome Browser**

2. Click on the menu on the toolbar of the browser next to the window url insertion for navigation
3. Select Settings
4. Click Show Advanced Settings
5. In the "Privacy" section click on the "Content settings" button
6. In the "Cookies" section you can change the following settings for cookies:
7. Allow data to be saved locally
8. Change local data only until you close the browser
9. Prevent sites from setting cookies
10. Blocking third party cookies and site data
11. Managing exceptions for some websites
12. Deleting one or all cookies

### 1. Run the **Mozilla Firefox Browser**

2. Click on the menu on the toolbar of the browser next to the window url insertion for navigation
3. Select Options
4. Select the Privacy panel
5. Click Show Advanced Settings
6. In the "Privacy" section click on the "Content settings" button
7. In the "Tracking" section you can change the following settings for the cookie:
8. Ask the sites not to make any tracking
9. Communicate to the sites the willingness to be tracked
10. Do not communicate any preference regarding the tracking of personal data
11. From the "Chronology" section it is possible:
12. By enabling "Use custom settings" select to accept third-party cookies parts (always, from the most visited sites or never) and to keep them for a certain period (until the their expiry date, at the closing of Firefox or to ask each time)
13. Remove individual stored cookies

1. Run the Internet **Explorer Browser**
  2. Click the Tools button and choose Internet Options
  3. Click on the Privacy tab and in the Settings section change the device to scrolling according to the desired action for cookies:

  2. Tap on Settings and then Safari

  4. To delete all cookies stored by Safari, tap Settings, then Safari and finally on Cancellate Cookie and data

  6. Never accept cookies: all cookies will never be saved.
